

Regular School Board Meeting
September 24, 2007
5:30 p.m.

PRESENT:

Ms. Barbara Hathcock, president, called the meeting to order. Other Board members present were Ms. Shannon Blatt, Ms. Jeannie Cole, Dr. David Hunton, Ms. Yvonne Keaton-Martin, and Dr. Deanie Mehl, Mr. Wyman R. Wade, Jr. was not present. Dr. Benny Gooden, superintendent, Dr. Gordon Floyd, Deputy Superintendent and Ms. Carolyn Kincaid, executive secretary were also present.

The pledge of allegiance was recited and Ms. Keaton-Martin gave the invocation.

Ms. Hathcock welcomed representatives from the Children 's Service League Board, Partners in Education Advisory Board, FSPS Foundation Board, City Council PTA and PTA Presidents and thanked them for their service and support for the Fort Smith Public Schools.

Dr. Gooden presented the 2007 Annual Report to the Public.

Dr. Hunton made a motion, seconded by Ms. Cole, to approve the minutes of the August 27, 2007 regular school board meeting. The vote for approval was 6/0.

Ms. Cole made a motion, seconded by Dr. Mehl, to approve the recommendations for employment. The vote for approval was 6/0.

Dr. Gooden and Dr. Hunton presented certificates to Amanda Bulger for being named Arkansas Career Orientation Teachers' Association Teacher of the Year and Jeff Williams for receiving the 2007 Lowell Manning Coach of the Year Award from the Arkansas Activities Association.

.Dr. Gooden noted that the school board election was held Tuesday, September 16, and Dr. David Hunton was elected, At-Large, Position 5 and Ms. Barbara Hathcock was elected, Position 6, Zone 1. The vote for continuation of the 36.5 mill school tax was 1,455 for the tax and 332 against the tax. Ms. Cole made a motion, seconded by Ms Keaton-Martin to accept the returns as a matter of record, and incorporate the results into the minutes. The vote for approval was 6/0. Dr. Gooden noted that all required ADE reports have been filed for Cycle 1, and thanked Ms. Ellen Terry and Dr. Brenda Sellers for their efforts in this monumental task.

He also noted that the Team Visit associated with District Accreditation by AdvancED, parent corporation of the North Central Association/Commission on Accreditation and School Improvement will occur on October 15-17.

The Arkansas School Board New Board member workshop is scheduled for Tuesday, October 16 in Little Rock and the ASBA Region 4 Meeting for our district is scheduled for Thursday, October 18, 2007, hosted by the Greenwood School District.

Dr. Gooden informed the Board that Howard Elementary School has been approved for a Tornado Shelter.
